Program Activity Update

The 2007 Program Overview contains specific details on what design features can qualify for an incentive. It covers eligibility, how to participate, and also provides references to other Idaho Power energy efficiency programs and other resources.

What Is “Proof of Payment?”

In order to process a *Building Efficiency* incentive payment, the Final Application must be accompanied by supporting documentation, including proof of payment. Proof of payment can be a purchase order, billing invoice, or any other document showing the quantity of goods purchased and that the amount due has been paid.

When a billing invoice is not available, it is acceptable to submit vendor invoices, or any document signed by the project architect, engineer, contractor or vendor that is on company letterhead and includes:

- the quantity, make and model of equipment;
- a statement of verification that the equipment was purchased by the applicant, and
- a statement of verification that the equipment was installed at the applied facility.

Idaho Building Code to Change in 2008

The 2007 Idaho legislature passed, and the governor signed, House Bill 84. HB 84 will update the state’s building code effective January 1, 2008. At that time, Idaho’s code for new building energy use will shift from the 2003 International Energy Conservation Code (IECC) to the 2006 version of the IECC.

The *Building Efficiency* program will have to change with the changing code. The current program qualifications and other details will still be in effect for the remainder of 2007. There will be some program changes after that. We will give you as much notice of those changes as we can.
