**About the Audit**

Idaho Power Company offers financial support to conduct feasibility audits by Idaho Power-approved contractors to encourage its larger customers to adopt applications or process improvements that lead to improved electrical energy efficiency.

This application form, along with an audit proposal, must be submitted to an Idaho Power Customer Representative or Program Engineer, and then approved by Idaho Power prior to initiating the actual audit.

For qualifying audits, Idaho Power provides an incentive of up to 50% of the audit cost, but not to exceed \$10,000. Each customer site is limited to one detailed audit each year.

**Qualification Criteria**

This program is available to all Idaho Power Company Schedule 9 and Schedule 19 customers located in Idaho with a Basic Load Capacity (BLC) of at least 500 kW. Other large customers who have entered into IPUC-approved special contracts with Idaho Power Company pursuant to Schedule 19 may also qualify.

Only audits conducted by eligible consulting engineers and specialists will be funded. Idaho Power Company, in its sole discretion, shall determine the eligibility of the consulting engineers and specialists to perform the audits based on qualifications, past performance and other appropriate criteria, on a per application basis.

**Detailed Audit Agreement**



THIS AGREEMENT is made this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between IDAHO POWER COMPANY, an Idaho Corporation (Idaho Power or Company) and \_\_\_\_\_ (Customer). The entities are referred to collectively herein as the "Parties."

**WITNESSETH**

WHEREAS, the Company has developed the Custom Efficiency Program (Program) to promote electrical energy efficiency in the commercial and industrial sector of its service territory through the implementation of applications or process improvements that lead to improved electrical energy efficiency; and

WHEREAS, the Customer has a billing demand of 500 kW or greater, and desires to participate in the Program through the performance of a professional audit described in the Customer Efficiency Program Audit Application (Application) attached hereto with Idaho Power Job Number \_\_\_\_\_.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. The Customer shall have the audit completed by an Idaho Power-approved contractor within 90 days of Idaho Power's acceptance of the Application.
2. Idaho Power shall pay Customer an incentive of up to 50%, not to exceed \$10,000 for the cost of the professional audit provided the terms and conditions described herein are completely satisfied. For the Customer to be reimbursed for 50% of the cost of the professional audit, not to exceed \$10,000, the Customer must submit a copy of the Auditor's invoice for the work performed.
3. The Customer agrees to provide the Company with a hardcopy of the Auditor's final report within 90 days of completion of the audit. The Customer agrees to allow the Company full and free access to the audit records including measurements, drawings and calculations used in the audit for a period of five (5) years following Customer's receipt of the audit payment. The Company may undertake such measurements, calculations, studies and reports of the audit as it deems desirable to determine that the audit meets the objectives of the Program. The Customer hereby grants Idaho Power reasonable access to the site described in the Application to permit the Company to undertake such measurements, calculations, studies and reports. The Parties shall enter into an appropriate confidentiality agreement, if necessary, to limit the disclosure of audit information to the Idaho Public Utilities Commission and other authorized entities.
4. **The Company assumes no responsibility or liability for the effectiveness or technical performance of the professional audit and the Company makes no warranty that the Customer will realize any energy savings as a result of the audit. There is no warranty of merchantability or fitness for a particular purpose and any and all implied warranties are disclaimed. The Customer agrees to indemnify the Company against any claims or damages resulting from injuries to persons or damage to property arising in connection with this Agreement or implementation of the audit, except as caused by the Company's sole negligence or other breach of legal duty. In no event shall the Company be responsible for any special, incidental, consequential, punitive, exemplary or indirect damages in tort or contract under any indemnity provision or otherwise.**
5. The Customer shall be responsible for any taxes levied or assessed upon the professional audit and the reimbursement payments.
6. The Customer certifies that Customer's in-house labor and overheads are not included in the cost of the audit and are not part of the incentive to be paid by Idaho Power.
